**INVITATION TO BID**

Mactan-Cebu International Airport Authority (MCIAA), through its Bids and Awards Committee (BAC), invites bidders to submit bids for the hereunder contract:

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (Revised IRR) of Republic Act No. 9184 (RA 9184). Prospective bidders should have completed, from the date of submission and receipt of bids, a similar project as defined in the BDS with a value of at least fifty percent (50%) of the ABC, and meet the other minimum eligibility requirements stated in the Instructions to Bidders (ITB). Bidding is restricted to sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be obtained by prospective bidders on May 9, 2018 up to May 28, 2018 @ 1:30 P.M., at the New MCIAA BAC Office, formerly 2GO Building, Cargo Area, Airport Road, Mactan-Cebu International Airport, upon payment of a non-refundable fee of P2,800.00. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB. Late bids shall not be accepted. Bids received that exceed the ABC shall automatically be rejected at bid opening.

All particulars relative to Bid Security, Performance Security, Pre-Bid Conference, Eligibility Check, Evaluation of Bids, Post-Qualification and Award of Contract, among others, shall be governed by the pertinent provisions of RA 9184 and its 2016 Revised IRR.
