Prospective bidders should have completed, from the date of submission and receipt of bids, a similar project with a value of at least fifty percent (50%) of the ABC, and meet the other minimum eligibility requirements as will be discussed during the Pre-negotiation Conference. Bidding is restricted to sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Late bids shall not be accepted. Bids received that exceed the ABC shall automatically be rejected at bid opening.

All particulars relative to Performance Security, Pre-Bid Conference, Eligibility Check, Evaluation of Bids, Post-Qualification and Award of Contract, among others, shall be governed by the pertinent provisions of RA 9184 and its 2016 Revised IRR.
